Review Request from Chatham County for Former Henry Siler School


The consensus of the Board of Commissioners was to discuss the Former Henry Siler School at a future meeting.

NEW BUSINESS


Thompson stated that late this afternoon an airplane landing at the Airport, didn't put out its landing gear. The plane is damage but no injuries have been reported.
